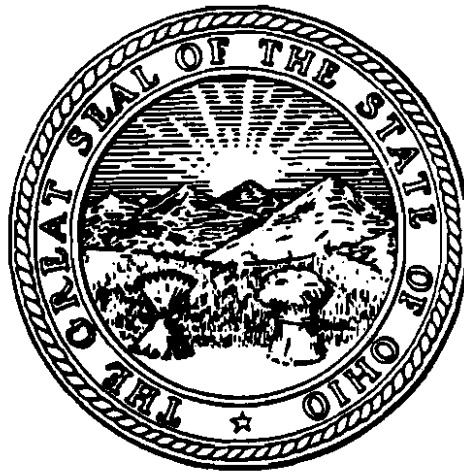

Dear Ladies and Gentlemen:

As required by Section 1901.12 of the Ohio Revised Code, The Rocky River Municipal Court herewith submits it's thirty-eighth Annual Report for the year 1995.

The contents of this report are based on data assembled and tabulated by Ben K. Wright, Clerk of Courts and his staff. The following data are noteworthy for the year 1995.

1. The total funds received from all sources in the year 1995 amounted to \$2,607,600.51 an increase of \$260,705.62 over 1994.
2. The total number of traffic/criminal cases filed in 1995 were 15,362. The statistical breakdown includes: 12,246 traffic, 799 DUI/BAC, 1,901 misdemeanors and 416 felonies which is a decrease of 561 cases filed in 1994.
3. 1995 civil case filings in the Rocky River Municipal courts Civil Division were 1,373. The total costs collected on these cases were \$190,796.50.
4. The total amount of court costs disbursed to the City of Rocky River in 1995 from all sources amounted to \$1,086,762.23 which is an increase of \$160,111.98 over 1994.

I want to take this opportunity to thank Ben K. Wright who retired 12-31-95 as the Clerk of Courts. Ben served the Court for 31 years, the last 24 as the elected Clerk. He served with honor, dedication and distinction. I personally thank Ben K. Wright for making my transition to the office as smooth as possible. We all wish Ben and his wife, Kathleen, the best of health and happiness in his retirement.

I want to thank the entire staff of the Clerks Office for their hard work and dedication. I would also like to thank the Judges of the Court, Maureen Adler Gravens and Donna Congeni Fitzsimmons, and their staffs for their contributions and making a new Clerk feel welcome.

Finally, great appreciation is extended to Rocky River's Mayor, Don Umerley, Rocky River City Council, Police Officers and Officials of the Rocky River Court District for their assistance.
