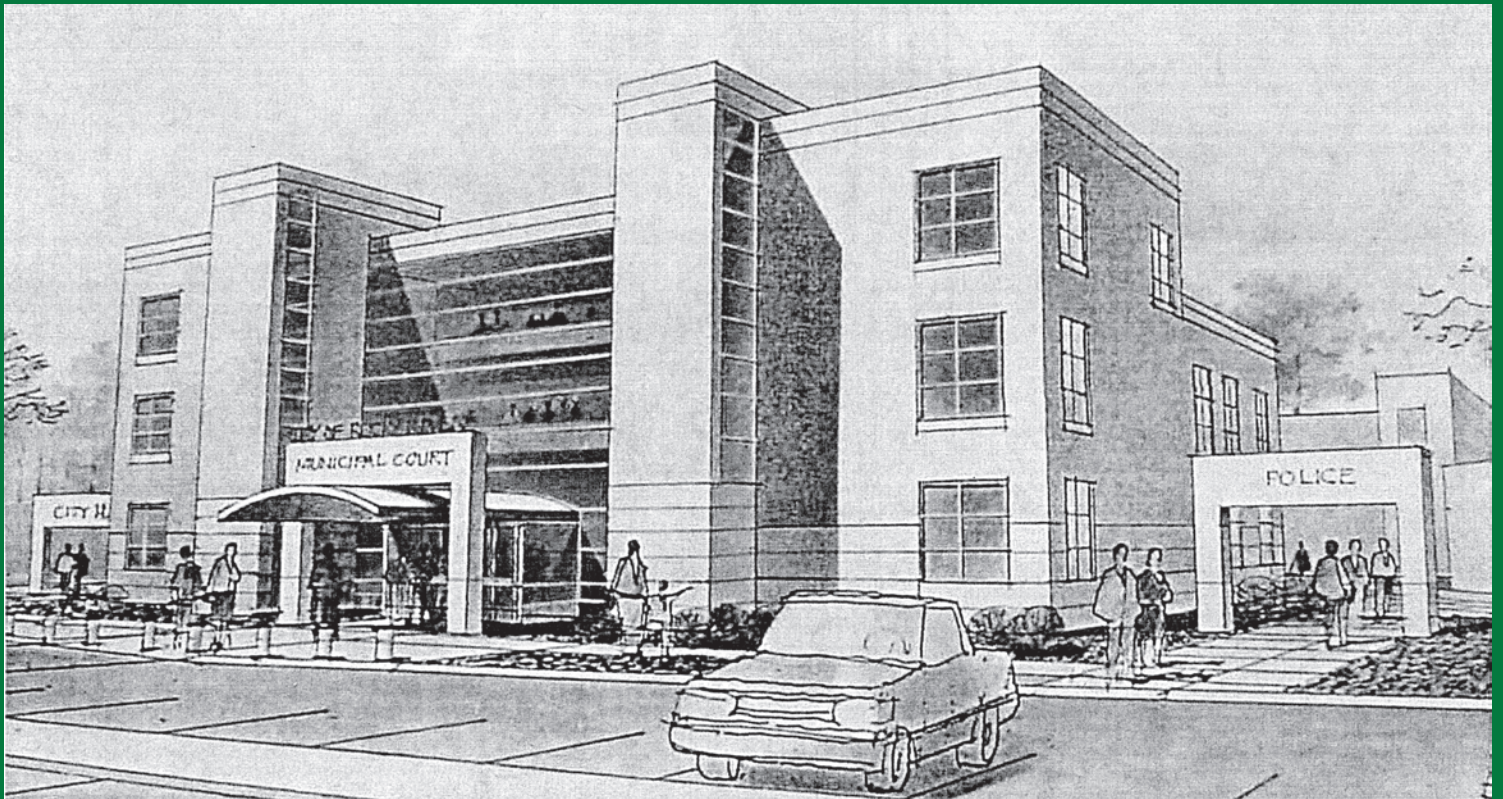

Dear Ladies and Gentlemen:

As required by R.C. §1901.14(A)(4), the Annual Report for 2017 is hereby submitted by the Rocky River Municipal Court. The content of this report is based on data assembled and tabulated by Clerk of Court Deborah F. Comery. The following data is noteworthy for the year 2017:

1. There were 11,394 cases filed in criminal/traffic consisting of 7,754 traffic, 494 OVI/BAC, 2,545 criminal misdemeanors, 479 felonies and 122 parking violations. Criminal/traffic case filings decreased dramatically by 2,537 cases from 2016.

There were 2,729 cases filed in civil and small claims consisting of 1,933 civil, 791 small claims, 3 rent escrows and 2 trusteeships. The total civil case filings increased by 365 cases from 2016.

The court experienced an 18% decrease in criminal / traffic cases and a 15% increase in civil / small claims cases during 2017. The court has no control over the number of criminal / traffic or civil / small claims cases filed each year.

2. The total amount of court costs disbursed to the City of Rocky River from all sources was \$2,526,105.13. Of these monies, \$1,819,392.64 was designated for the Court's operational revenue. These funds were used against operational Court expenditures of \$1,758,577.62. \$192,160.20 was placed in the Computer Fund to maintain and enhance the Court's computer system, video arraignment equipment, telephone and internet services, and the courtroom audio recording system. \$274,371.00 was placed in the Special Projects Fund to continue to pay down the principal and interest debt of the Courthouse building as well as expensing the salary and benefits of a portion of the Court's Magistrates and maintaining the Court's security camera system and magnetometer. \$227,059.19 was placed in the Court's Probation Services Fund to assist in the overall operations of the Community Control Department including a portion of the salary and benefits of the Department's employees. \$13,122.10 was placed in the Court's Indigent Drivers Alcohol Treatment (IDAT) Fund to help with indigent offenders' court ordered alcohol assessment and treatment.

RRMC completed its 21<sup>st</sup> consecutive year without a deficit. A sincere thank you to all court staff for their diligence to duty and continuing efforts to keep the services provided to all who come to this Court at the highest level of excellence.



3. A portion of fine money collected in 2017, payments from the State of Ohio, along with costs noted above were placed in two funds established by the Ohio State Legislature and governed by the Ohio Revised Code to be utilized by the Court to monitor and treat indigent drug and alcohol offenders. A total of \$55,931.35 was placed in the IDAT Fund in 2017 to cover a portion of the treatment for indigent offenders. A total of \$29,814.91 was placed in the Court's IDIAM Fund in 2017 to cover a portion of the monitoring of indigent offenders.

The Court continues to utilize its video arraignment capabilities to include any video equipped law enforcement facility within the State of Ohio and beyond. This process saves jurisdictional police departments' time and transportation expenses along with providing safety benefits to both public and staff within the Courthouse.

Since 2003, our website, [www.rrcourt.net](http://www.rrcourt.net), has become an integral part of the Court's public outreach. **eFiling**, **ePayments**, public records access, weekly court dockets, local court rules, jury service information, probation information, these Annual Reports and much more can be found on our website. We continue to accept **ePayments** primarily for those defendants who are allowed to waive their traffic ticket or who choose to pay their fines and costs after their case has been adjudicated. Most of our court documents, both current and historical, continue to be imaged and are available for viewing on the website.


**eFiling** continues to be fully utilized for our Civil filings and increasingly so in our Criminal/Traffic Department. This software allows for complete control by the filer to submit **eDocuments** for filing as well as the ability to submit their filing fee payment online.

We continue to use **FedEx** Signature Service as the major vehicle for our service and the speed of delivery and percentage of successful deliveries has remained extremely high. **FedEx** service information is downloaded automatically to the individual case docket within a maximum of 14 days versus an average of 30-45 days with Certified Mail (often beyond the required time allowed by law for service). Visitors to a case file can track, in almost real time, the progress of all **FedEx** deliveries.

The Clerk's Office continues to provide space for a deputy clerk from the Cuyahoga County Probate Court's Marriage License Bureau. On the third Friday of each month, residents of Cuyahoga County may pre-register for a marriage license and come to Rocky River Municipal Court to complete the process without having to travel to the downtown Probate Court facility. After participating in this pilot program for five years now, we continue to be one of the busiest locations and have found this to be a successful cooperative effort.

Again, I want to thank the staff of the Clerk's Office for their amazing work and exceptional dedication again this year. I would also like to thank Administrative / Presiding Judge Donna Congeni Fitzsimmons and Judge Brian F. Hagan and their staffs for their help and guidance during the year. Grateful appreciation is also extended to Rocky River Mayor Pamela E. Bobst, Rocky River City Council, Rocky River Law Director Andrew Bemer as well as all of the Police Officers and Officials of the Rocky River Municipal Court District for their continued assistance and cooperation.

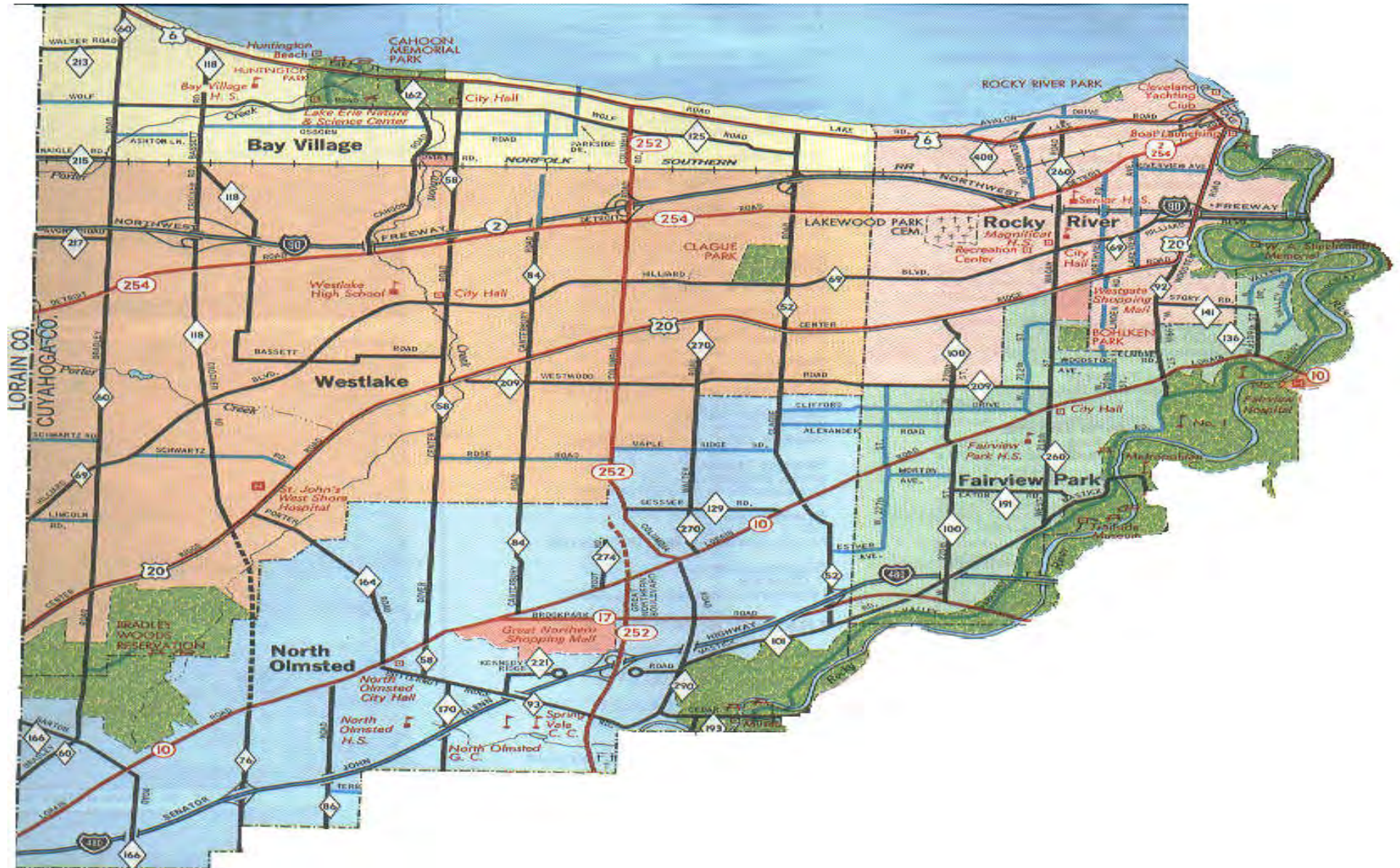

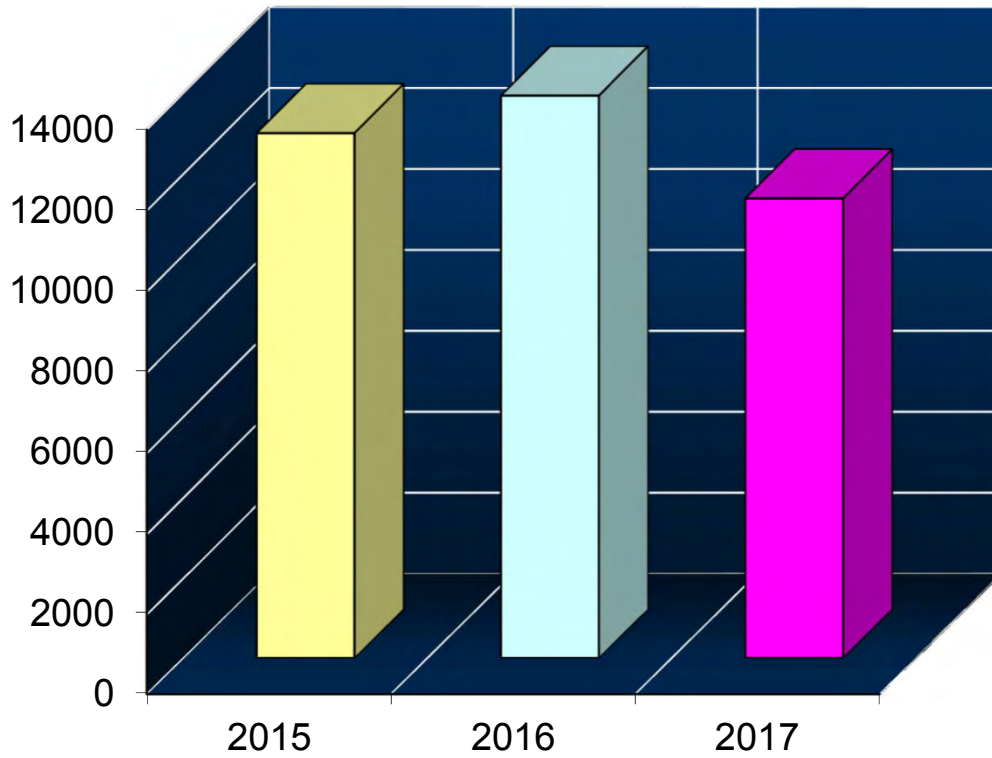

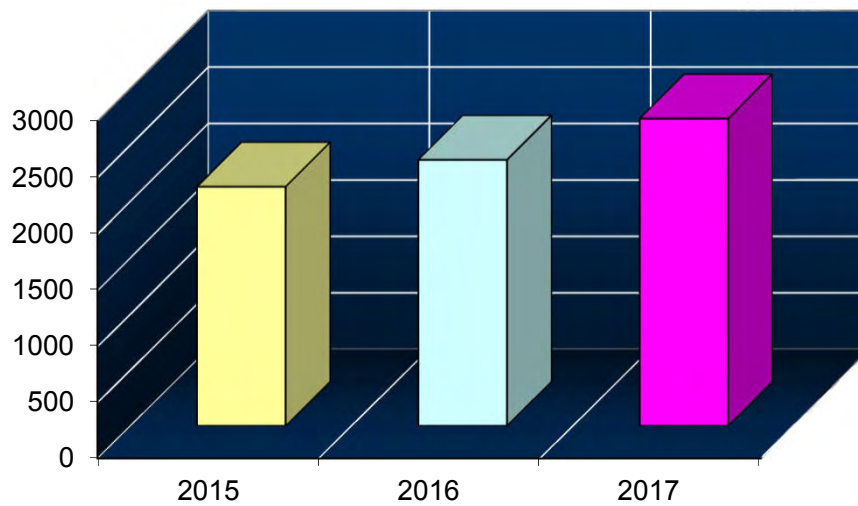

## **2017 COMMUNITY CONTROL DEPARTMENT OVERVIEW**

Rocky River Municipal Court has been a part the Greater Cleveland Drug Court Suburban Expansion Grant for the past 5 years. In 2017, we referred 22 offenders to the program, had 12 graduates and many pending. The Greater Cleveland Drug Court is committed to assist with intervention, treatment and rehabilitation of non-violent drug/alcohol offenders. Also, this year the grant has expanded to utilize medication assisted treatment.

The Community Control Department provides a variety of services to the court and the community. The Department provides assistance to offenders and diversion participants by obtaining services including community mental health, substance abuse, counseling and intervention programs. The Community Control Department monitors offenders to reduce crime and protect the public.

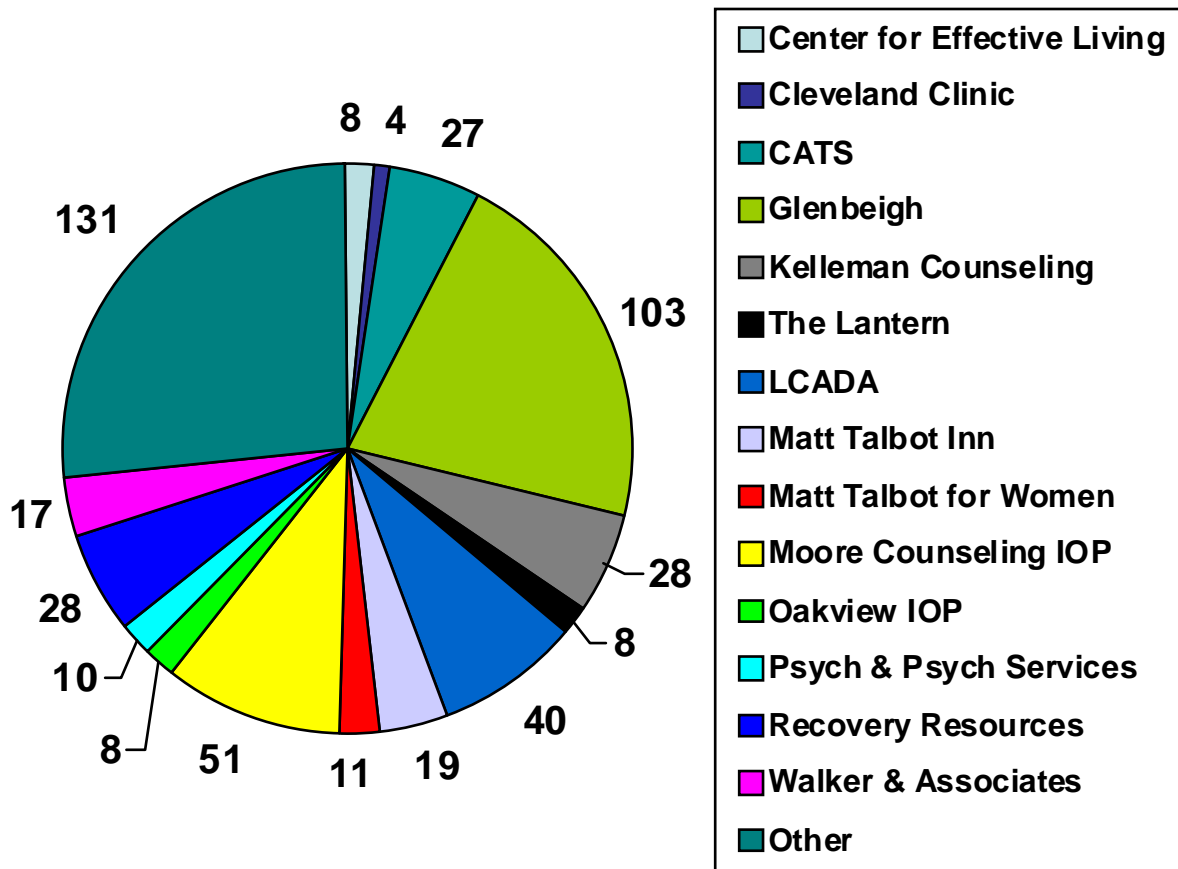

The *Indigent Drivers Alcohol Treatment Fund* and the *Indigent Drivers Interlock and Monitoring Fund* provide treatment and monitoring services for persons arrested while operating a vehicle under the influence. The funds come from fees and fines collected as legislated by the Ohio General Assembly. The Rocky River Municipal Court utilizes these funds to assist OVI offenders who are unable to afford substance abuse treatment and alcohol monitoring. In 2017 the Rocky River Municipal Court spent \$ 49,772.95 for treatment and \$49,502.17 for monitoring.

### **ORAS Risk Assessment**

The Rocky River Municipal Court has been using the Ohio Risk Assessment for 5 years with most cases that include a pre-sentence investigation. The Ohio Risk Assessment has expanded to use the ORAS-MST (a misdemeanor specific screening tool). The Ohio Risk Assessment has been found to be a valid predictor of misdemeanor recidivism. The screening tool helps our judges, magistrates and community control officers use of resources for higher risk offenders versus lower risk offenders. Of the 1163 total offenders rated, 518 were low risk offenders, 428 were moderate risk and 217 were high risk offenders.

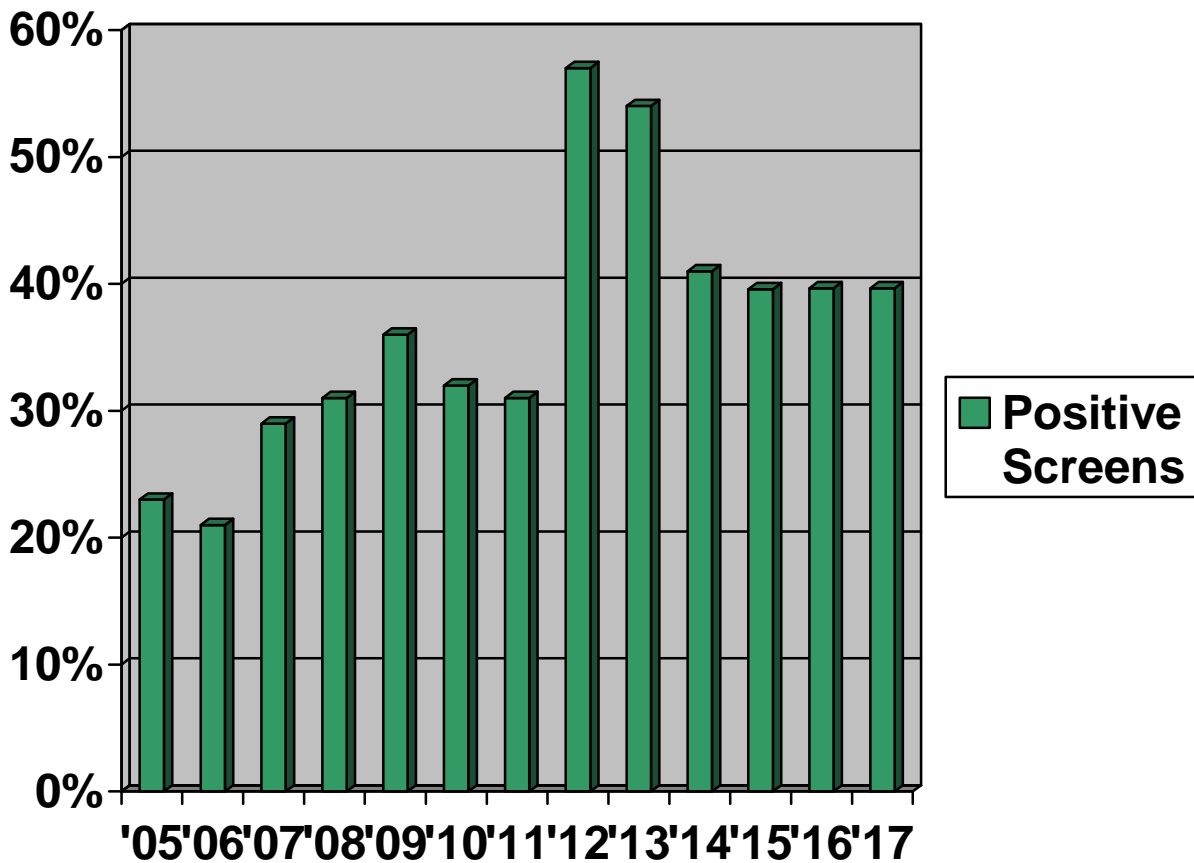

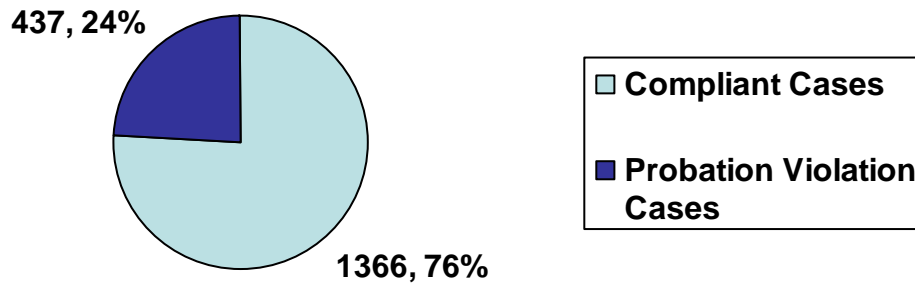

### **Presentence Investigation Cases / Pre-Trial cases opened in 2017**

In 2017, 475 pre-sentence investigations were completed. These investigations include offender history, risk assessment, criminal history, and substance abuse information necessary for sentencing. Out of the community control departments total number of cases, 26% of the offenders have pre-sentence investigations. Community Control officers are involved in pre-trial cases. In 2017 we opened 108 pre-trial cases. Many of these cases involve monitoring treatment for substance abuse and mental health, house arrest, GPS, scram- secure remote alcohol monitoring and ignition interlock.

### **Young Adult Alcohol Diversion Program**

The Rocky River Municipal Court Young Adult Alcohol Diversion Program provides a short period of supervision and education for the purpose of assisting eligible offenders in changing the behavior that brought them before the court. Offenders are required to complete an alcohol education program, complete at least 20 hours of community service and maintain good behavior for the duration of the program.

### **Selective Diversion Program**

The Rocky River Municipal Court Selective Diversion Program provides a short period of supervision and education for the purpose of assisting offenders in changing the behavior that brought them before the court. Offenders are to complete any counseling, class, or community service that the court finds necessary prior to the dismissal date. Entry into Selective Diversion is through prosecutor recommendation. Included in the Selective Diversion Program is the Theft Diversion Program, a six-month period of supervision and education for the purpose of assisting eligible offenders in changing the behavior that brought them before the court. Offenders in the Theft Diversion Program are to complete a four-week Theft Intervention Program, complete at least 20 hours of community service and maintain good behavior for the duration of the program.
