Dear Ladies and Gentlemen:

As required by R.C. §1901.14(A)(4), the Annual Report for 2021 is hereby submitted by the Rocky River Municipal Court (RRMC). The content of this report is based on data assembled and tabulated by Clerk of Court Deborah F. Comery and the Rocky River Municipal Court Community Control Department. The following data is noteworthy for the year 2021:

1. 2021 continued as another year of dealing with the COVID-19 Coronavirus. As was the case with 2020, we, again, have experienced a deficit year. I would like to extend the Court's appreciation to all the Cities of our Jurisdiction for their financial support and especially to the City of Rocky River who has had to carry the majority of the assistance for the Court to continue operations.
2. We continued to comply with the COVID restrictions of social distancing and mask wearing. RRMC distributed masks to anyone coming to the Court who was not vaccinated and was required to wear a mask, or anyone else who may not have a mask and would like one. We continued to mark off the six-foot distancing where lines might occur to assist the public. Plexiglass remains in place in all public areas and courtrooms to aid the distancing effort. As CDC restrictions continue to change, RRMC is adapting to meet their requirements.
3. Technology has been a wonderful assist with continued use of our video arraignment capabilities to connect remotely with any video-equipped law enforcement facility within the State of Ohio and beyond as needed. RRMC had continued its use of ZOOM as a means to enable remote courtroom interaction with attorneys, defendants, prosecutors, law enforcement, witnesses and the judicial officials to maintain an almost uninterrupted court docket.
4. In an effort to assist with the finances this year, the Court has continued to obtain operational funding by aggressively and successfully applying for Grant dollars to cover the replacement of much of our aging technology. Over the last 18 months, we have received \$203,322.65 in Grant Funding to cover the replacement of the Court's servers, scanners, desktop and laptop computers, telephone system, plexiglass, Community Control expenses for house arrests and alcohol monitoring due to restricted permissions to house prisoners at Cuyahoga County Jail, as well as an emergency notification phone system. A special "thank you" to our new Chief Community Control Officer, Colleen Eynon, for her able involvement in acquiring these Grant funds.

5. There were 6,663 cases filed in criminal/traffic consisting of 4,304 traffic, 364 OVI/BAC, 1,477 criminal misdemeanors, 460 felonies and 58 parking violations. Criminal/traffic case filings continued to decrease if only by 36 cases from 2020.


There were 2,211 cases filed in civil and small claims consisting of 1,728 civil, 481 small claims, 2 rent escrow and 0 trusteeship. The total civil case filings increased by 248 cases from 2020.

It would now appear that the court's traffic caseload has finally settled out to what may be our new normal. The court has no control over the number of criminal / traffic or civil / small claims cases filed each year.

6. The total amount of court costs disbursed to the City of Rocky River from all sources was \$1,738,327.64. Of these monies, \$1,272,363.68 was designated for the Court's operational revenue. These funds were used against operational Court expenditures of \$2,353,995.77. \$116,566.63 was placed in the Computer Fund to maintain and enhance the Court's computer system, video arraignment equipment, telephone and internet services, and the courtroom audio recording system. \$187,041.19 was placed in the Special Projects Fund to continue to pay down the principal and interest debt of the Courthouse building. \$155,554.64 was placed in the Court's Probation Services Fund to assist in the overall operations of the Community Control Department including a portion of the salary and benefits of the Department's employees. \$6,801.50 was placed in the Court's Indigent Drivers Alcohol Treatment (IDAT) Fund to help with indigent offenders' court ordered alcohol assessment and treatment.
7. December 1, 2022 will finally mark the last payment of the Court's Bond obligations that began two decades ago as we pay back the \$3,700,000 loan for the building of the current RRMC Courthouse. With this last payment, RRMC is proud to say that the Courthouse structure was achieved without the use of one tax dollar of any of our constituents. It is also the hope that with the end of these payments, we will have more dollars available to help defray future deficit years. Until such time as we might see our caseload return to prior "normal" years, we may continue to struggle.
8. Pursuant to the Ohio Revised Code as created by the Ohio State Legislature, a portion of OVI fine money collected in 2021 and disbursed to the State of Ohio, was returned to this Court and placed in our IDAT and IDIAM Funds. A portion of these monies, as well as the costs noted above, were utilized to monitor and treat indigent drug and alcohol offenders. A total of \$36,095.02 was placed in the IDAT Fund in 2021 to cover a portion of the treatment for indigent offenders. A total of \$47,972.01 was placed in the Court's IDIAM Fund in 2021 to cover a portion of the monitoring of those same indigent offenders.
9. Due to the Pandemic, the Cuyahoga County Probate Court's Marriage License Bureau has stopped their program with RRMC to provide easier access for those individuals who would like to procure a marriage license. After participating in this pilot program for seven plus years, we hope to have them back as soon as might be permissible.

As always, I want to thank the staff of the Clerk's Office for their amazing work and exceptional dedication again this year. I would also like to thank Administrative/Presiding Judge Donna Congeni Fitzsimmons and Judge Brian F. Hagan and their staffs for their assistance during the year. Grateful appreciation is also extended to Rocky River Mayor Pamela E. Bobst, Rocky River City Council, Rocky River Law Director Andrew Bemer as well as all of the Police Officers and Officials of the Rocky River Municipal Court District for their continued assistance and cooperation.






2021 COMMUNITY CONTROL DEPARTMENT OVERVIEW

The Rocky River Community Control Department continued to make changes in how we delivered our services in 2021 due to COVID-19. Our office was closed for face-to-face appointments from January 1, 2021 through May 1, 2021. During that period of time, we continued a high level of contact and referral to services with offenders. The Community Control Department continued to complete Pre-Sentence Investigations and were available for all court proceedings.

As a result of COVID-19, we applied for and received a grant to support off-site drug screening and scam / house arrest to replace jail commits as Cuyahoga County jail continued to be closed to most misdemeanor offenders.

The Community Control Department provides a variety of services to the court and the community. The Department provides assistance to offenders and diversion participants by obtaining services including community mental health, substance use disorder, counseling and intervention programs. The Community Control Department monitors offenders to reduce crime and protect the public.

The *Indigent Drivers Alcohol Treatment Fund* and the *Indigent Drivers Interlock and Alcohol Monitoring Fund* provide treatment and monitoring services for persons arrested while operating a vehicle under the influence. The funds come from fees and fines collected as legislated by the Ohio General Assembly. The Rocky River Municipal Court utilizes these funds to assist OVI offenders who are unable to afford substance abuse treatment and alcohol monitoring. In 2021, the Rocky River Municipal Court spent \$29,071.81 for treatment and \$54,291.30 for monitoring.

ORAS Risk Assessment

The Rocky River Municipal Court has been using the Ohio Risk Assessment for 9 years on pre-sentence investigation cases and defendants placed on probation. The Ohio Risk Assessment has expanded to use the ORAS-MST (a misdemeanor specific screening tool). The Ohio Risk Assessment has been found to be a valid predictor of misdemeanor recidivism. The screening tool helps our judges, magistrates and community control officers use of resources for higher risk offenders versus lower risk offenders. Of the 356 total offenders rated, 266 were low risk offenders, 127 were moderate risk offenders, and 63 were high risk offenders.

Pre-sentence Investigation Cases / Pre-Trial cases opened in 2021

In 2021, 281 pre-sentence investigations were completed. These investigations include offender history, risk assessment, criminal history, and substance abuse information, which is necessary for sentencing. Community Control officers are involved in pre-trial cases. In 2021, we had 128 active pre-trial cases. Many of these cases involved monitoring treatment for substance abuse and mental health, house arrest, GPS, SCRAM (secure remote alcohol monitoring) and ignition interlock. During COVID-19 we continued to keep a high level of involvement for public safety and for victims and offenders.

Competency to Stand Trial

The Rocky River Municipal Court is impacted by the increasing numbers of offenders with mental health issues where competency to stand trial has been questioned. In 2021, we had one competency to stand trial requested by defense counsel. One request for competency was ordered by the Court. The outcome...competent.

MENTAL HEALTH LIAISON PROJECT/BYRNE GRANT

The Mental Health Liaison Project/Byrne Grant has been renewed after a positive history of support since 2002. The primary goal is to decrease the number of mentally ill persons processed through the judicial system by linking them to the appropriate services. Of the 99 referrals in 2021, there were referrals from:

Substance Use/ Mental Health Treatment Referrals:

In 2021, our Community Control Department continued to make referrals to mental health and substance use disorder treatment. To increase the success of offenders, we utilized medication assisted treatment, inpatient and outpatient treatment, sober living and mental health treatment. Rocky River Municipal Court refers to jail reduction, specialized dockets for drug court, mental health, veteran and human trafficking. **Approximately 576** of our offenders were referred to and received these services.

Rocky River Municipal Court has been a part of the Greater Cleveland Drug Court Suburban Expansion Grant for the past 8 years. In 2021, we referred 1 offender to the program, had 3 graduates, and 3 still in the program. The Greater Cleveland Drug Court is committed to assist with intervention, treatment and rehabilitation of non-violent drug/alcohol offenders. The grant has expanded to utilize medication-assisted treatment.

Drug Screening

Due to the pandemic, The Rocky River Municipal Court had to change the process for drug screening from on-site to off-site. We applied for and received a grant to provide screening to those who could not afford it.

JAIL REDUCTION PROGRAM

The Jail Reduction Program was established to reduce jail crowding and link offenders that have substance abuse problems with treatment. However, Cuyahoga County jail was closed for misdemeanor offenses for periods in 2021 due to COVID-19, which resulted in fewer referrals.

Offenders are required to complete an alcohol education program, complete at least 20 hours of community service, and maintain good behavior for the duration of the program.

Selective Diversion Program

The Rocky River Municipal Court Selective Diversion Program provides a short period of supervision and education for the purpose of assisting offenders in changing the behavior that brought them before the court. Offenders are to complete any counseling, class, or community service that the court finds necessary prior to the dismissal date. Entry into Selective Diversion is through prosecutor recommendation. Included in the Selective Diversion Program is the Theft Diversion Program, a six-month period of supervision and education for the purpose of assisting eligible offenders in changing the behavior that brought them before the court. Offenders in the Theft Diversion Program are to complete a four-week Theft Intervention Program, complete at least 20 hours of community service and maintain good behavior for the duration of the program.
