Dear Ladies and Gentlemen:

As required by R.C. §1901.14(A)(4), the Annual Report for 2022 is hereby submitted by the Rocky River Municipal Court (RRMC). The content of this report is based on data assembled and tabulated by Clerk of Court Deborah F. Comery and the Rocky River Municipal Court Community Control Department. The following data is noteworthy for the year 2022:

1. Thankfully, 2022 saw a reduction and then a termination of all COVID 19 restrictions within the Courthouse.
2. I am sorry to say that we, again, have experienced a deficit year. We were able to reduce our 'employee expenditures' this year by over \$200,000, but that effort was offset by an increase in office expenditures of \$116,000. In non-deficit years, the Court was able to utilize the various Funds at our disposal to offset our diminishing revenue due to a continuing reduction of case filings. There was a small uptick this year in Traffic cases but not anywhere near enough to be genuinely effective. Couple that with having depleted our Funds in an effort to do all that we can to offset our financial standing, those Funds are now almost gone. We have little control over revenue but cost amounts will be reviewed in 2023.
3. I would like to extend the Court's appreciation to all the Cities of our Jurisdiction for their financial support and especially to the City of Rocky River who has had to carry the majority of the assistance for the Court to maintain operations. We will continue to make every effort to keep expenditures to a minimum.
4. On a brighter note, after 21 years of making principal and interest payments averaging \$225,000.00 per year, RRMC paid the last payment covering the Bond, that was required to build our current court facility, on December 1, 2022. Fortunately, in 2011, RRMC was financially viable enough to request and receive a Bond review whereby we renegotiated our agreement with Huntington Bank reducing our debt payments by five years. Given our current status, that renegotiation was a blessing beyond compare!

With this last payment, RRMC is proud to say that the building of the Courthouse structure was achieved without the use of one direct tax dollar from any of our constituents. It is also the hope that with the end of these payments, we will have more dollars available to help defray future deficit years. Until such time as we might see our caseload return to prior "normal" years, we may continue to struggle.

5. The Court continues to reach out for additional funding by aggressively applying for Grant dollars. The funds for which we apply are limited as well since all the courts in the State of Ohio are applying for those very same funds. RRMC realizes the need to maintain a current and viable computer system. Given the age of our Case Management Software (24 years and counting), the need to upgrade is becoming critical as we approach an 'end of life'. This is not a small dollar investment. We have begun to look at the possibilities open to us to improve our technological capabilities and the acquisition of Grant dollars is critical to our goal.
6. There were 7,424 cases filed in criminal/traffic consisting of 5,002 traffic, 410 OVI/BAC, 1,530 criminal misdemeanors, 417 felonies and 65 parking violations. Criminal/traffic case filings increased this year by 761 cases.


There were 2,272 cases filed in civil and small claims consisting of 1,685 civil, 581 small claims, 5 rent escrow and 1 trusteeship. The total civil case filings increased by 61 cases from 2021.

The court has no control over the number of criminal / traffic or civil / small claims cases filed each year.

7. The total amount of court costs disbursed to the City of Rocky River from all sources was \$1,780,154.33. Of these monies, \$1,302,394.21 was designated for the Court's operational revenue. These funds were used against operational Court expenditures of \$2,264,252.96. \$124,442.46 was placed in the Computer Fund designed to maintain and enhance the Court's computer system, video arraignment equipment, telephone and internet services, and the courtroom audio recording system. \$199,546.20 was placed in the Special Projects Fund to complete the payments of the principal and interest debt of the Courthouse building. \$145,577.46 was placed in the Court's Probation Services Fund to assist in the overall operations of the Community Control Department including a portion of the salary and benefits of the Department's employees. \$8,194.00 was placed in the Court's Indigent Drivers Alcohol Treatment (IDAT) Fund to help with indigent offenders' court ordered alcohol assessment and treatment.
8. Pursuant to the Ohio Revised Code as created by the Ohio State Legislature, a portion of OVI fine money collected in 2022 and disbursed to the State of Ohio, was returned to this Court and placed in our IDAT and IDIAM Funds. A portion of these monies, as well as the costs noted above, were utilized to monitor and treat indigent drug and alcohol offenders. An additional \$16,637.00 was placed in the IDAT Fund in 2022 to cover a portion of the treatment for indigent offenders. An additional \$15,770.02 was placed in the Court's IDIAM Fund in 2022 to cover a portion of the monitoring of those same indigent offenders.

As always, I want to thank the staff of the Clerk's Office for their amazing work and exceptional dedication again this year. I would also like to thank Administrative/Presiding Judge Brian F. Hagan, Judge Donna Congeni Fitzsimmons and their staffs for their continued assistance during the year. Grateful appreciation is also extended to Rocky River Mayor Pamela E. Bobst, Rocky River City Council, Rocky River Law Director Michael O'Shea as well as all of the Police Officers and Officials of the Rocky River Municipal Court District for their continued assistance and cooperation.

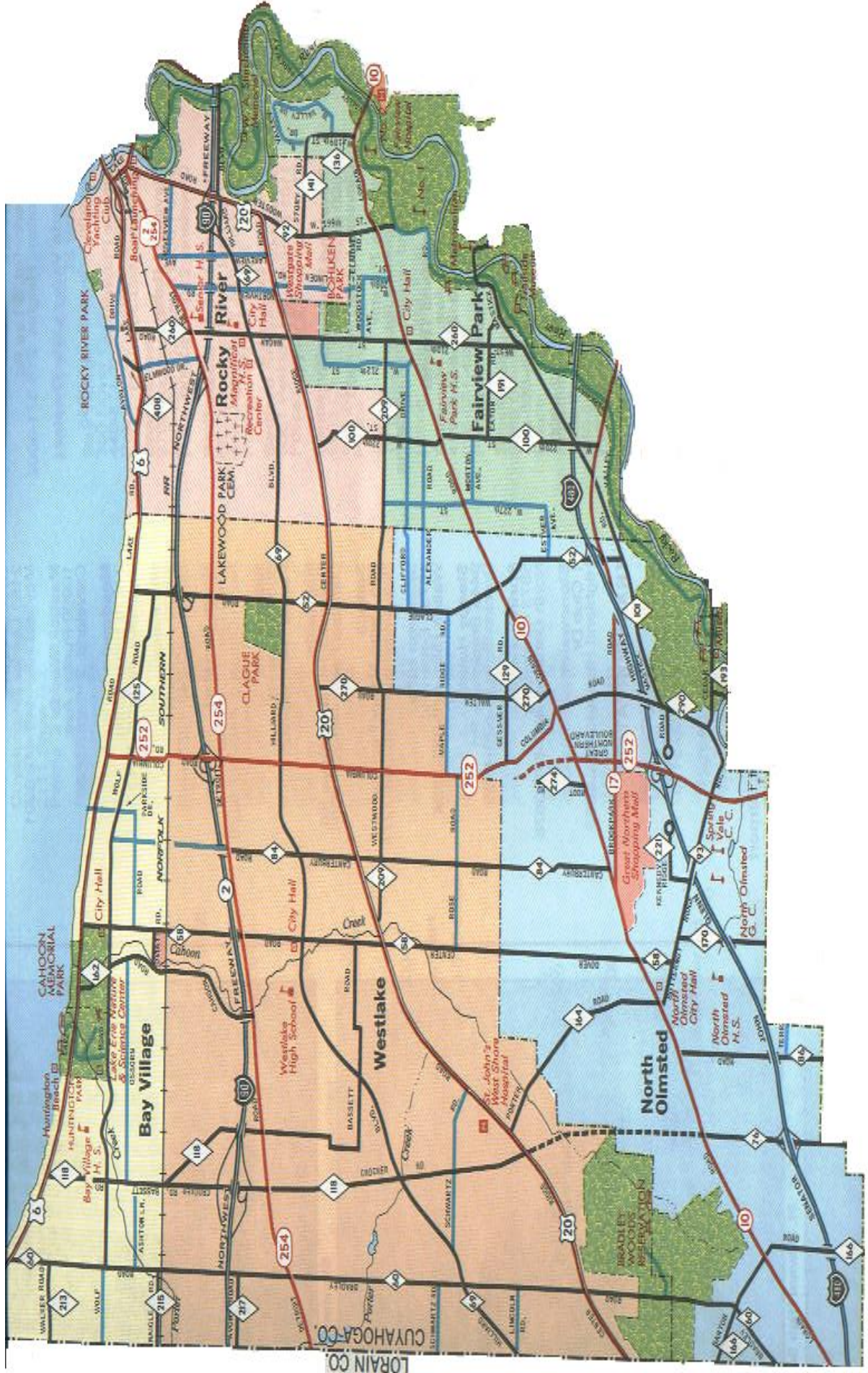

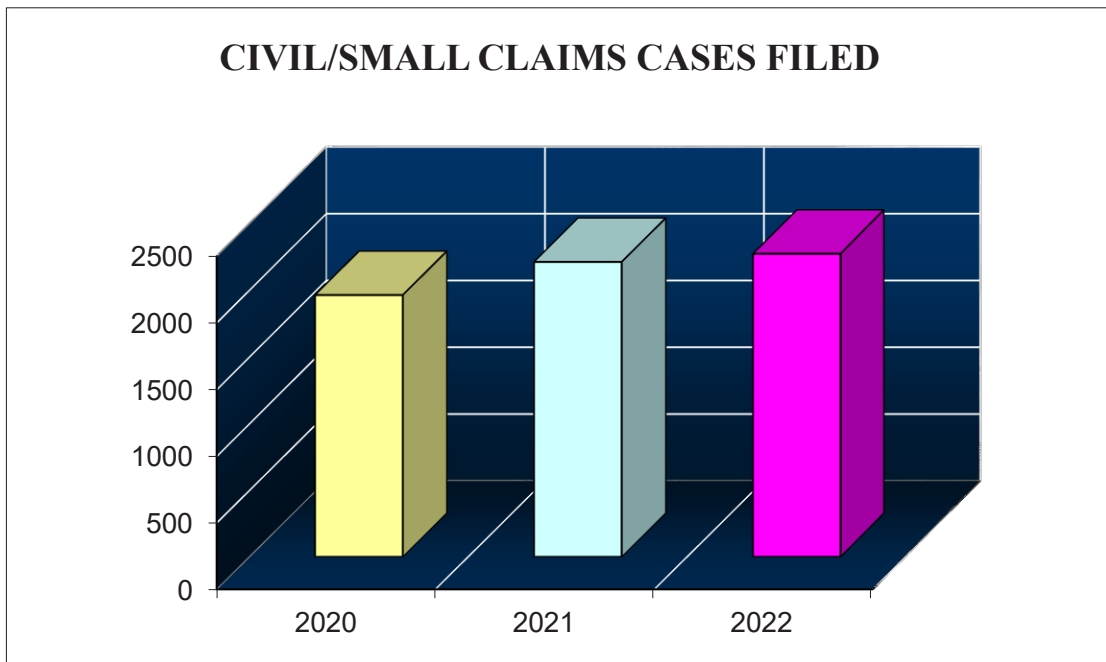
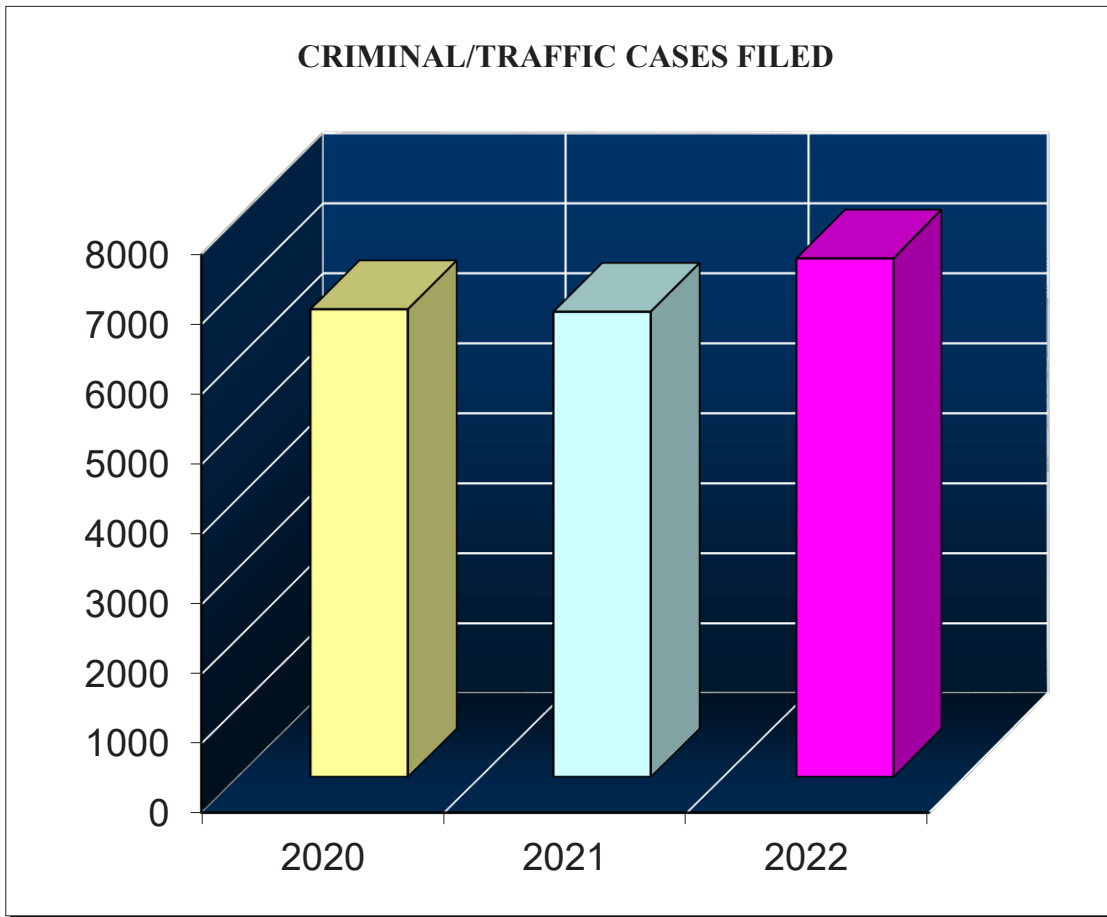

## **2022 COMMUNITY CONTROL DEPARTMENT OVERVIEW**

The Community Control Department provides a variety of services to the court and the community. The Department provides assistance to offenders and diversion participants by obtaining services including community mental health, substance use disorder, counseling and intervention programs. The Community Control Department monitors offenders to reduce crime and protect the public.

#### **2022 OVI (OPERATING A VEHICLE UNDER THE INFLUENCE) OFFENSES**

There were 410 OVI offenses in 2022 that required community control. OVI offender referrals are mandated to attend programs based on the level of offense. Additionally, EMHA (Electronically Monitored House Arrest), Ignition Interlock, and SCRAM (Continuous Alcohol Monitoring) are also utilized. The *Indigent Drivers Alcohol Treatment Fund* and the *Indigent Drivers Interlock and Alcohol Monitoring Fund* provide treatment and monitoring services for persons arrested while operating a vehicle under the influence. The funds come from fees and fines collected as legislated by the Ohio General Assembly. The Rocky River Municipal Court utilizes these funds to assist OVI offenders who are unable to afford substance abuse treatment and alcohol monitoring. In 2022, the Rocky River Municipal Court spent \$8,874.35 for treatment and \$39,366.10 for monitoring.

### ORAS Risk Assessment

The Rocky River Municipal Court has been using the Ohio Risk Assessment for 10 years on pre-sentence investigation cases and defendants placed on probation. The Ohio Risk Assessment has expanded to use the ORAS-MST (a misdemeanor specific screening tool). The Ohio Risk Assessment has been found to be a valid predictor of misdemeanor recidivism. The screening tool helps our judges, magistrates and community control officers use of resources for higher risk offenders versus lower risk offenders. **Of the 507 total offenders rated, 229 were low risk offenders, 194 were moderate risk offenders, and 84 were high risk offenders.**

### Pre-sentence Investigation Cases / Pre-Trial cases opened in 2022

In 2022, 249 pre-sentence investigations were completed. These investigations include offender history, risk assessment, criminal history, and substance abuse information, which is necessary for sentencing. Community Control officers are involved in pre-trial cases. In 2022, we had 104 active pre-trial cases. Many of these cases involved monitoring treatment for substance abuse and mental health, house arrest, GPS, SCRAM (secure remote alcohol monitoring) and ignition interlock. During COVID-19 we continued to keep a high level of involvement for public safety and for victims and offenders.

### **Competency to Stand Trial**

The Rocky River Municipal Court is impacted by the increasing numbers of offenders with mental health issues where competency to stand trial has been questioned. This year we had zero (0) competency cases.

### **MENTAL HEALTH LIAISON PROJECT/BYRNE GRANT**

The Mental Health Liaison Project/Byrne Grant has been renewed after a positive history of support since 2002. The primary goal is to decrease the number of mentally ill persons processed through the judicial system by linking them to the appropriate services. This year we had 11 evaluations completed with follow up recommendations.

### **Substance Use/ Mental Health Treatment Referrals:**

In 2022, our Community Control Department continued to make referrals to mental health and substance use disorder treatment. To increase the success of offenders, we utilized medication assisted treatment, inpatient and outpatient treatment, sober living and mental health treatment. Rocky River Municipal Court refers to jail reduction, specialized dockets for drug court, mental health, veteran and human trafficking. **Approximately 403** of our offenders were referred to and received these services.

Rocky River Municipal Court has been a part of the Greater Cleveland Drug Court Suburban Expansion Grant for the past 9 years. In 2022, we referred 22 offenders to the program, had 1 graduate, 2 fails, and 19 still in the program. The Greater Cleveland Drug Court is committed to assist with intervention, treatment and rehabilitation of non-violent drug/alcohol offenders. The grant has expanded to utilize medication-assisted treatment.

### **Drug Screening**

In 2022, the Community Control Department resumed collecting drug screens at the Court.

### **DUS Diversion**

In 2022, Rocky River Municipal Court reinstated the DUS diversion program. This program helps driving offenders regain a valid Driver's License. The offenders are given individual instructions on how to clear their driver's license suspensions through the BMV.

### **Young Adult Alcohol Diversion Program**

The Rocky River Municipal Court Young Adult Alcohol Diversion Program provides a short period of supervision and education for the purpose of assisting eligible offenders in changing the behavior that brought them before the court. Offenders are required to complete an alcohol education program, complete at least 20 hours of community service, and maintain good behavior for the duration of the program.

### **Selective Diversion Program**

The Rocky River Municipal Court Selective Diversion Program provides a short period of supervision and education for the purpose of assisting offenders in changing the behavior that brought them before the court. Offenders are to complete any counseling, class, or community service that the court finds necessary prior to the dismissal date. Entry into Selective Diversion is through prosecutor recommendation. Included in the Selective Diversion Program is the Theft Diversion Program, a six-month period of supervision and education for the purpose of assisting eligible offenders in changing the behavior that brought them before the court. Offenders in the Theft Diversion Program are to complete a four-week Theft Intervention Program, complete at least 20 hours of community service and maintain good behavior for the duration of the program.
